From there, she joined Blank Rome LLP, Philadelphia, where she started their immigration practice and was responsible for the day-today management of the practice. In 2014, after nearly 17 years of working at big law firms, she left Blank Rome to start her own practice. The Law Offices of Manuela Morais has grown to a total of 10 employees in just three years. One unique aspect of the firm is that its team of attorneys and paralegals currently consists solely of women. Going out on her own fostered an entrepreneurial spirit, which inspired a passion to encourage and support other women to do the same. Today, she serves as a member of the board of directors, as well as the chair of membership committee of Women Owned Law, a newly established organization with a mission of providing opportunities for women legal entrepreneurs to come together, support each other and help each other's firms prosper.

"Helping to get this organization off the ground is so important because it encourages women to pursue alternate career paths," Morais says. "The organization not only supports women who may be thinking about going out on their own, but also promotes and unifies women who already have established law firms."

She has also served as an adjunct professor at the University of Pennsylvania Law School. In each of these roles, she has worked to encourage women to have an entrepreneurial spirit, to take on leadership roles in the profession and to encourage career paths in immigration law.

As a business owner herself, Morais understands the struggles that businesses, both large and small, face on a day-to-day basis and how important it is to ensure that her clients' needs are met in the most quick, efficient manner. The majority of the firm's practice is dedicated solely to supporting businesses with immigration matters and bringing in foreign employees, while a smaller portion of the practice consists of handling individual matters such as marriage-based cases and deportation removals.

It also helps that I personally love a good challenge, and that I can connect and relate to people who are undergoing their immigration process."
