Leaving a toxic work environment, even though the money was great. It was a really tough decision that was about five years in the making, but ultimately I knew I had to prioritize my physical, spiritual and mental health over money.

I am not active on social media, either personally or professionally, but recently I decided to make a post on LinkedIn about my firm's two-year anniversary. I was so surprised by the amount of attention the post received, including a handful of referrals and two new clients.

I recently became a mentor to women students at my undergraduate university who want to go to law school. I never really had a mentor, so I am very excited to serve in this capacity.

What advice would you offer new business owners?

Don't give up! There will be many days when you will want to throw in the towel, but you have to keep pushing through. You never know the difference a year, a month or even a day can make.
