Tell us about a recent professional accomplishment of yours. One of my most meaningful accomplishments is the impact our work has on our clients. Recently, a client told me that our firm has been one of the best things to happen in his life, and it genuinely brought me to tears. It was a powerful reminder that our work goes far beyond numbers; it's about trust, transformation, and showing up for people in a way that truly makes a difference.

Tell us about a recent personal accomplishment of yours. I ran my fastest marathon in the 2025 Boston Marathon in 3 hours and 21 minutes after falling flat on my face at mile 21. I got mad, so I got up and decided I was going to run faster, and that I did!

What advice would you offer new business owners? Be clear about both your short-term and long-term goals, and be intentional in how you work toward them. Too many business owners start without a clear destination, which can limit their growth and create unnecessary detours. When you know where you're going, it's easier to make aligned decisions, measure progress, and build something sustainable.
